When enrolling your child at SHA, you are reserving the time, space, staffing and provisions for your child, whether your child attends or not. No credit will be given for the days when the preschool is officially closed. We appreciate your understanding.
No tuition adjustments will be made due to a pandemic or public health emergency. Reimbursements will not be issued for the month when a closure may happen. No credit will be given for the days when the preschool is officially closed.
All payments returned for non-sufficient funds will be charged a fee of \$32.00.
All payments are to be processed through Brightwheel and can be automated or manual. We do not accept cash or checks.
SHA is licensed by the State of California and must comply with all regulations mandated by the licensing agency. All necessary forms for admission must be completed entirely and be kept-up-to date. Because the information requested on these forms can be vital to a child's welfare and safety, deliberately falsifying school documents may be grounds for non-acceptance or release from the program.
SHA requires a <u>30-day written notice if your child is leaving the school</u> , verbal notification is not accepted. Tuition will only be prorated upon receipt of your written notice.
